# 一、成功增发1.69亿美元债

2019年9月9日及11月14日,公司分别增发美元债1亿及6900万美元,年利率均为13%,及均为平价发行,圆满完成2019年3亿美元债发行计划。

# 二、2019年四季度土地并购概况

2019年4季度,天誉置业共收购3幅地块,总楼面面积约93万平方米,收购资金19亿元,平均楼面价为人民币2148元/平方米。具体情况如下表:

#### I. Successful Tap Issuance of Notes Amounted USD169 Million

The first tap issuance of USD100 million notes on 9 September 2019 and the second tap issuance of USD69 million notes on 14 November 2019 successfully completed. Both are at an annual interest rate of 13% and at par value as issuing price. Such tap issuance help the Company successfully reach the target of issuing USD300 million Notes in 2019.

### **II.** Summary of Land Acquisition in Quarter 4, 2019

In the fourth quarter of 2019, the Company acquired about a total GFA of 930,000 sq.m., consisting of 3 pieces of land at a total consideration of RMB1900 million. The average floor price is RMB 2148 per sq.m.. Further information is listed below:

**Note:** The Company obtained 7 new projects covering GFA of approximate 2,480,000 sq. m. through bidding in primary land market and acquisition deals in second land market, which leads to a 67% increase in the Group's land bank when compared with last year. The total acquisition price is RMB3 billion and the average floor price is RMB1344 per sq. m.. Meanwhile, the Company also procured a construction management project of GFA of 160,000 sq. m. in Huiyang as its first brand output of project management.
